RESOLUTION #2022-13 to Set District Mill Levies**

(Pursuant to 39-5-128, C.R.S. and 39-1-111,  
C.R.S.)

A RESOLUTION LEVYING PROPERTY TAXES FOR THE YEAR 2022, TO HELP DEFRAY THE COSTS OF GOVERNMENT FOR THE NEDERLAND FIRE PROTECTION DISTRICT, COLORADO, FOR THE 2023 BUDGET YEAR.

**WHEREAS**, the Board of Directors of the Nederland Fire Protection District, has adopted the annual budget in accordance with the Local Government Budget Law on December 14th, 2022 and;

**WHEREAS**, the amount of money necessary to balance the budget for **general operating** purposes from property tax revenue is **\$1,206,949** and;

**WHEREAS**, the amount of money necessary to balance the budget for voter-approved **firefighter pension fund** is **\$37,091** and;

**WHEREAS**, the amount of money necessary to balance the budget for **abated property tax** is **\$971** and;

**WHEREAS**, the amount of money necessary to balance the budget for voter-approved Residential Assessment Rate (RAR) Impact Reduction is **\$29111** and;

**WHEREAS**, the 2022 valuation for assessment for the Nederland Fire Protection District as certified by the Boulder County Assessor(s) is **\$74,181,592**.

**NOW, THEREFORE**, BE IT RESOLVED/ORDAINED BY THE BOARD OF DIRECTORS OF THE NEDERLAND FIRE PROTECTION DISTRICT, COLORADO:

Section 1. That for the purpose of meeting all **general operating expenses** of the Nederland Fire Protection District during the 2023 budget year, there is hereby levied a tax of 15.287 mills upon each dollar of the total valuation for assessment of all taxable property within the Nederland Fire Protection District for the year 2022.

Section 2. That for the purpose of meeting all **firefighter pension fund expenditures** of the Nederland Fire Protection District during the 2023 budget year, there is hereby levied a tax of 0.5 mills upon each dollar of the total valuation for assessment of all taxable property within the Nederland Fire Protection District for the year 2022.

Section 3. That for the purpose of meeting all **abated property tax** expenses of the Nederland Fire Protection District during the 2023 budget year, there is hereby levied a tax of 0.013 mills upon each dollar of the total valuation for assessment of all taxable property within the Nederland Fire Protection District for the year 2022.

Section 4. That for the purpose of meeting all voter-approved **Residential Assessment Rate (RAR) Impact Reduction** expenses of the Nederland Fire Protection District during the 2023 budget year, there is hereby levied a tax of 0.392 mills upon each dollar of the total valuation for assessment of all taxable property within the Nederland Fire Protection District for the year 2022.

Section 5. That the Fire Chief is hereby authorized and directed to immediately certify to the County Commissioners of Boulder County, Colorado, the mill levies for the Nederland Fire Protection District as hereinabove determined and set.
