1 Evening of Vehicle Extrication

1 Training on EMS Operations

We hosted the Denver Chop Shop. 2 full days of vehicle extrication training with sales reps from Holmatro extrication tools. We had attendance of 27 people from Central City Fire, Cheyenne Wells, Timberline Fire, and Nederland Fire

I completed the 3rd section of the COTC (Chief Officer Training Course) in Denver last week.

Vehicles:

5631: Backup camera installed.

5601: somehow sustained some damage to the left rear compartment. Daniel Murphy was able to straighten it most out.

5652: cylinder 7 misfire. It has been repaired. I will be looking at a replacement for it when the Sheriffs vehicles become available.

5632 needed new tires. We were able to take the original tires from 5631 and use them. Daniel Murphy dismounted and remounted those on 32's rims.

5659: vacuum pump replaced.
