Ballot Question 5A Shall the eligible electors of the Nederland Fire Protection District be given the right to choose directors of the district without the limitation imposed by Article XVIII Section II of the Colorado Constitution regarding limitation of terms of office?

## 2008 Ballot Issue

SHALL THE NEDERLAND FIRE PROTECTION DISTRICT TAXES BE INCREASED BY 4.000 MILLS ANNUALLY, COMMENCING FOR TAXES IN 2008, DUE AND PAYABLE IN 2009, FOR PURPOSES OF INCREASING EMERGENCY SERVICES PERSONNEL LEVELS AND TO FUND OPERATIONAL EXPENSES; SUCH TAXES TO BE IMPOSED IN ADDITION TO THE DISTRICT'S CURRENT MILL LEVY OF 11.120 MILLS, AND; SHALL THE REVENUE FROM SUCH TAXES AND INVESTMENT INCOME THEREON, CONSTITUTE VOTER-APPROVED REVENUE CHANGES AND BE COLLECTED AND SPENT BY THE DISTRICT WITHOUT REGARD TO ANY SPENDING, REVENUE RESTRICTIONS, OR OTHER LIMITATION CONTAINED WITHIN ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION, C.R.S. SECTION 29-1-301, OR ANY OTHER LAW, AND WITHOUT LIMITING, IN ANY YEAR, THE AMOUNT OF OTHER REVENUE THAT MAY BE COLLECTED AND SPENT BY THE DISTRICT?

## 2018 Ballot Issue

BALLOT ISSUE 5A: WITHOUT INCREASING TAXES, SHALL THE NEDERLAND FIRE PROTECTION DISTRICT BE AUTHORIZED BEGINNING ANNUALLY IN 2019 (FOR TAX YEAR 2018) TO EXTEND AND RETAIN THE REVENUE THAT WAS VOTER APPROVED TO BE GENERATED THROUGH THE EXPIRING 20-YEAR CONSTRUCTION BOND MILL LEVY FIRST LEVIED IN 1998 THAT WAS USED FOR FIRE STATION CONSTRUCTION, THROUGH AN EXTENSION OF SUCH MILL LEVY IN THE AMOUNT OF 2.940 MILLS, THE LOWEST MILL PREVIOUSLY LEVIED FOR THE CONSTRUCTION BOND, SUCH TAXES TO BE IMPOSED IN ADDITION TO THE DISTRICT'S CURRENT MILL LEVY OF 11.847 MILLS, FOR THE PURPOSES OF ADMINISTRATION, GENERAL OPERATIONS, AND CAPITAL IMPROVEMENTS; AND SHALL SUCH TAX PROCEEDS CONTINUE TO BE COLLECTED AND SPENT BY THE DISTRICT AS VOTER APPROVED REVENUE AND SPENDING CHANGES IN EACH YEAR, WITHOUT REGARD TO ANY SPENDING OR REVENUE LIMITATIONS CONTAINED IN ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION AND SECTION 29-1-301, COLORADO REVISED STATUTES?

BALLOT ISSUE 5B: WITHOUT IMMEDIATELY INCREASING TAXES, AND ONLY IF THE CURRENT RESIDENTIAL ASSESSMENT RATE IS REDUCED BELOW THE CURRENT RATE OF 7.2% ESTABLISHED PURSUANT TO SECTIONS 3 OF ARTICLE X OF THE COLORADO CONSTITUTION, AND SUCH RATE REDUCTION RESULTS IN A DECREASE IN DISTRICT TAX REVENUES FROM THE DISTRICT'S VOTER APPROVED MILL LEVY, SHALL THE NEDERLAND FIRE PROTECTION DISTRICT (DISTRICT) BE PERMITTED TO INCREASE ITS PROPERTY TAX MILL LEVY TO OFFSET ANY SUCH DECREASE IN REVENUES THAT MAY DECREASE FIRE, RESCUE, AND EMERGENCY SERVICES AS DETERMINED BY THE DISTRICT'S BOARD OF DIRECTORS; AND SHALL SUCH TAX PROCEEDS BE COLLECTED AND SPENT BY THE DISTRICT AS VOTER APPROVED REVENUE AND SPENDING CHANGES IN EACH YEAR, WITHOUT REGARD TO ANY CONSTITUTIONAL OR STATUTORY SPENDING OR REVENUE LIMITATIONS INCLUDING THOSE CONTAINED IN ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION AND SECTION 29-1-301, COLORADO REVISED STATUTES?

BALLOT ISSUE 5C: WITHOUT INCREASING TAXES, SHALL THE NEDERLAND FIRE PROTECTION DISTRICT BE AUTHORIZED TO REALLOCATE THE TAX REVENUE PREVIOUSLY APPROVED BY VOTERS FOR EXCLUSIVE USE FOR VOLUNTEER PENSION PROGRAM TO FUND OTHER FORMS OF A VOLUNTEER INCENTIVE PROGRAM, SUCH AS LENGTH OF SERVICE AWARD PROGRAMS, CALL STIPENDS, AND/OR OTHER SIMILAR PROGRAMS AFTER THE NEDERLAND FIRE PROTECTION DISTRICT VOLUNTEER PENSION FUND IS FULLY FUNDED; AND SHALL SUCH TAX PROCEEDS BE COLLECTED AND SPENT BY THE DISTRICT AS VOTER APPROVED REVENUE AND SPENDING CHANGES IN EACH YEAR, WITHOUT REGARD TO ANY SPENDING OR REVENUE LIMITATIONS CONTAINED IN ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION AND SECTION 29-1-301, COLORADO REVISED STATUTES?
